Notes on Completing Form SA1

General — Form SA1 must be completed by a parent/guardian if they wish to claim Free School Meals or a Uniform Grant for their child(ren). The form must be completed by the parent/guardian who is in receipt of Income Support / Jobseeker's Allowance (Income Based) or Child Tax Credit only (Working Tax Credit is not an entitlement)

Evidence of Benefits need to be seen by the Awards and Benefits Section at Thurrock Council with initial application.

Free School Meals are available to pupils whose parent(s)/guardian are in receipt of the benefits stated above.

The Awards and Benefits Section must be informed immediately when a claim for Income Support / Jobseeker's Allowance (Income Based) Child Tax Credit has stopped, as you will no longer be entitled to Free School Meals. You will have to repay the money for any meals taken after the benefit has been withdrawn.

If you are claiming Free School Meals only you should not complete question's 9,10 and 12 of this form.

A **Uniform Grant** is payable to a parent/guardian if they are in receipt of benefits stated above and have a child or children of secondary school age.

Uniform Grants can be paid twice for pupils in Secondary School. This can be paid in Years 7 and 9 or 10, or in Years 7 or 8 and 10. A payment will not be made two years in a row.

If you are claiming a Uniform Grant only you should not complete question 8 of this form. Question 12 will only need to be filled in if you do not have a bank/building society account.
